



Blue Benefits Terms and Conditions

Blue Benefits Subscription (hereinafter referred to as “**Blue Benefits**”) means the annual subscription consisting of a compilation of special offers which entitles the holder and members to certain benefits, as specified in the present Terms and Conditions.

Holder of Blue Benefits (hereinafter referred to as “**holder**”) means the person that shall benefit from the special offer compilation, nominated as the holder of the annual subscription during the registration formalities.

Member of Blue Benefits (hereinafter referred to as “**member**”) means the person that shall benefit from the special offer compilation, nominated by the holder during the registration formalities; infants cannot be nominated as members of the annual subscription.

Blue Benefits is associated with a Blue Air Account and can be activated online, via the Company’s website and/or the Company’s Mobile Application, by completing the registration formalities and by paying the annual subscription fee.

Blue Benefits shall be valid for a period of 12 (twelve) calendar months starting from its activation.

Blue Air offers clients the possibility of purchasing the following 3 (three) types of Blue Benefits:

- “**Blue Benefits Together**” – for the amount of **39.99 EUR / year** – offers clients the possibility to have access to special offer compilations for the holder and 1 (one) extra member;
- “**Blue Benefits Family**” **Annual Subscription** – for the amount of **74.99 EUR / year** – offers clients the possibility to have access to special offer compilations for the holder and 3 (three) extra members; and



- **“Blue Benefits Friends” Annual Subscription** – for the amount of **149.99 EUR / year** – offers clients the possibility to have access to special offer compilations for the holder and 8 (eight) extra members.

Blue Benefits special offer compilation consists of discounts such as:

- 12 EUR discount on airfare (applicable per passenger per flight segment); and
- up to 6 EUR discount on baggage (applicable per passenger per flight segment):
 - 3 EUR discount on checked-in baggage weighting up to 10kg and measuring a maximum of 55 cm x 40 cm x 20 cm;
 - 6 EUR discount on checked-in baggage weighting up to 23kg / 32kg and measuring a maximum of 100 cm x 80 cm x 30 cm.

In addition to the above, the holder shall automatically receive information about member-only promotional offers, through a newsletter.

The above-mentioned special offer compilation cannot be combined with other special offers and/or promotions offered by Blue Air unless specifically advised so by the airline.

Blue Benefits does not guarantee the availability of discounted fares on all routes and at all times. Moreover, fare levels lower than 19.99 EUR, as well as non-regular flights (for example, charter flights and/or code-share flights) may not be discounted through Blue Benefits.

In order for the special offer compilation to apply to bookings, the services must be purchased through the holder’s Blue Air Account. The holder must be, at all times, among the passengers in the bookings, while the member(s) of the annual subscription may differ for every booking, without exceeding the maximum number of extra members according to the chosen subscription.

Name changes are not allowed for the holder, however, such changes are allowed for the member(s) of the annual subscription in accordance with [Blue Air’s Travel Conditions](#).

If the holder legally changes its name during the validity period of the annual subscription, the holder is required to contact Blue Air through the [contact form](#) available on the Company’s website



in order to report the situation and submit the documents attesting the name change in order for Blue Air to operate the necessary changes in the system.

Blue Air reserves the right to change the Blue Benefits Terms and Conditions, at any time, with the prior notification of the holder.

The holder shall provide accurate and true personal information during the registration formalities. The Company is committed to respecting the clients' privacy, by complying with all applicable data protection laws and regulations, including the General Data Protection Regulation (EU) 2016/679 (the "GDPR"). As follows, the Company will collect certain information ("personal data") provided by the client during the registration formalities (for example name, surname, e-mail address, date of birth, nationality, client type (title, gender), home address, telephone number, etc.) and process said personal data in order to offer the services described in these Terms and Conditions, as well as inform the client regarding the Company's products, services and promotional offers through the newsletter subscription. [Blue Air's Travel Conditions](#) shall apply to any services purchased through the Blue Benefits Annual Subscription.

Blue Benefits Annual Subscription is non-refundable and non-transferable.

The holder must notify the Company upon becoming aware of any unauthorized use of his membership.

Services purchased through Blue Benefits shall not be offered for commercial purposes on any other platforms.

Blue Air reserves the right to refuse membership to any person and/or terminate membership at any time in case of breach of these Terms and Conditions.

By activating Blue Benefits, the holder shall be subscribed to Blue Air's Newsletter in order to receive marketing communications. The holder shall have the right to cancel the Newsletter



subscription, at any time, through the “unsubscribe” option which is included in each marketing communication.
