

Blue Benefits Terms and Conditions

Blue Benefits Annual Subscription means the special offer compilation, operated based on and according to the present Terms and Conditions and Blue Air's Travel Conditions, which entitles Holder and Members to certain benefits as specified herein.

Holder of the Blue Benefits Annual Subscription means the person named as the holder of the Annual Subscription during the registration formalities for the Blue Benefits Annual Subscription. Depending on the type of Annual Subscription chosen, the holder of the Annual Subscription may appoint a specified number of Members of the Blue Benefits Annual Subscription that shall benefit from the special offer compilation.

Blue Air offers clients the possibility of purchasing three types of annual subscriptions. The "Blue Benefits Together" Annual Subscription offers clients the possibility to have access to special offer compilations for the holder of the Annual Subscription and 1 (one) extra member. The "Blue Benefits Family" Annual Subscription offers clients the possibility to have access to special offer compilations for the holder of the Annual Subscription and 3 (three) extra members. By becoming a Holder of the Blue Benefits Annual Subscription, the client shall automatically receive information about member-only promotional offers, as well as be subscribed to Blue Air's newsletter. The client can unsubscribe from the newsletter at any time.
